- communicate in one foreign language at level B1 and in another foreign language at the level of at least A2 of the Common European Framework of Reference for Languages, be motivated to deepen language competences;
- apply scientific, technical, IT and mathematical knowledge, skills and procedures in practical contexts and in solving problems in various areas of life;
- work safely and at an advanced level with digital technologies and their software, and keep up with their development;
- search for, process and critically evaluate information, use algorithmic thinking, communicate and collaborate in online environments, and create digital content and models;
- understand the basic principles of information systems, analyse their structure and functions, design data models and adapt interfaces to user needs;
- be well versed in different social and value systems, as well as social, political, legal and economic processes of everyday life, and demonstrate financial and media literacy;
- adapt to changing social, economic and technological conditions, and make responsible economic decisions;
- strive for the highest quality of one's own work, services and products in accordance with technological procedures and quality standards;
- choose optimal solutions in real-life work and personal situations based on the interconnection of environmental, economic and social factors;
- observe the principles of occupational health and safety, and fire protection.

#### Vocational competences:

- offer and sell catering, accommodation, spa, currency exchange, transport and other services closely related to tourism;
- apply geographical, historical and art-historical knowledge of important tourist destinations in the Czech Republic, Europe and worldwide when organising tours and providing tour guiding services;
- provide tour guiding services in domestic and international tourism, prepare and deliver tour guiding commentary and maintain tour guide documentation;
- communicate and interact professionally with clients in Czech and a foreign language;
- use information technologies when searching for and providing information in tourism services;
- perform reception duties and provide accommodation services;
- effectively present the services of hotels and other categories of accommodation establishments;
- understand business and entrepreneurial activities in tourism and recognise the basic legal aspects of business in tourism;
- maintain business administration, keep records of the movement of assets, products and services, and monitor the financial performance of the establishment;
- calculate the prices of products and services and ensure their contractual sale;
- use marketing tools to prepare offers and promote tourism products and services;
- carry out basic human resource activities in tourism services.

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

Graduates may find employment in the tourism services sector, performing activities related to the offer and sale of tours, tour guiding, and the provision of accommodation, catering, transport, spa, information and other tourism services.

Examples of possible job positions: travel agency or tour operator staff member, tourist information centre employee, receptionist, tour guide, or public administration officer responsible for tourism development.
